By using our websites, software, or services, you agree to the terms of this Privacy Policy. Winmostar reserves the right to update or modify this Privacy Policy at any time by posting the revised version on our website.

1. Information We Collect

We may collect the following categories of information:

- Information you provide voluntarily: name, title, institution, address, email, phone number, login credentials, and any other details you provide when you:
 - Request a sales quote or trial license for Winmostar software.
 - o Register for an event (e.g., symposiums, webinars, training).
 - Create a user account on our website.
 - o Contact us via email or web forms.

- Cookies and similar technologies: Our website uses cookies and web beacons to manage sessions, verify login credentials, and improve site functionality.

2. How We Use Your Information

We process personal information for purposes including:

- To manage your account, process registrations, orders, and billing.

Winmostar Inc. Privacy Policy for residents and companies in California

Winmostar Inc. ("Winmostar," "we," or "us") recognizes the importance of privacy and transparency. This Privacy Policy explains how we collect, use, disclose, and safeguard your information. It also explains the rights of California residents under the California Consumer Privacy Act of 2018 (CCPA) and its amendments.

By using our websites, software, or services, you agree to the practices described here.

1. Information We Collect

We collect the following categories of personal information:

- Identifiers: name, email address, phone number, login credentials, IP address.
- Commercial information: records of products or services purchased, obtained, or considered.
- Internet/technical information: browsing activity, IP address, browser type, operating system, referring website, cookie data.
- **Professional or educational information**: institution, role/title, or information provided in job applications.
- Other information you provide: when requesting a demo, support, or registering for events.

We do **not** collect "sensitive personal information" unless legally required (e.g., for employment applicants).

2. Sources of Information

We collect information from:

- Automatically from your interactions with our website and software (cookies, analytics).
- Third parties that provide event registration, payment, or support services.

3. Use of Information

We use your personal information to:

- Provide, support, and improve our software and services.

- Conduct internal analytics and business operations.
- Comply with legal obligations.

4. Disclosure of Information

We may disclose your personal information for business purposes to:

6. Your Rights Under CCPA

- Right to Know: You can request details about the categories and specific pieces of personal information we have collected about you, the sources, and purposes of collection.
- **Right to Delete**: You can request deletion of your personal information, subject to certain exceptions (e.g., to comply with law, complete transactions).
- **Right to Correct**: You can request correction of inaccurate personal information.
- **Right to Opt-Out of Sale/Sharing**: You can opt out of any "sale" or "sharing" of your personal information (as defined under CCPA).
- **Right to Non-Discrimination**: We will not discriminate against you for exercising your privacy rights.

1. Introduction

We at **Winmostar Inc.** ("Winmostar," "we," or "us") greatly value your privacy. Protecting your personal data and ensuring transparency is a top priority. This Privacy Policy explains how we collect, process, and safeguard your personal data in accordance with the **General Data Protection Regulation (GDPR)** and applicable national laws.

Our websites and services can generally be used without providing personal data. However, if you wish to access certain features (e.g., registering for an account, downloading software, applying for jobs), the processing of personal data may be necessary.

2. Definitions

This Privacy Policy uses terms defined in Article 4 GDPR. For clarity, we explain the most important terms here:

- **Personal Data**: Any information relating to an identified or identifiable natural person.
- **Data Subject**: The individual whose personal data is processed.
- Processing: Any operation on personal data, such as collection, storage, use, or disclosure.
- Restriction of Processing: Marking stored personal data to limit future processing.

- **Pseudonymisation**: Processing personal data so that it cannot be attributed to a specific person without additional information.
- **Controller**: The entity that determines the purposes and means of processing (Winmostar Inc.).

- **Processor**: A service provider processing personal data on behalf of the controller.
- Recipient: A natural or legal person or authority to which personal data is disclosed.
- **Third Party**: Any entity other than the data subject, controller, or authorized processors.
- **Consent**: A freely given, specific, informed, and unambiguous indication of a data subject's wishes.

5. Categories of Data We Collect

We may collect the following categories of personal data:

- 1. **Identifiers**: name, email address, phone number, title, institution.
- 2. **Account Information**: login credentials, password, license details.
- 3. **Transaction Information**: billing address, payment data (processed via third-party providers).
- 4. **Technical Data**: IP address, browser type, operating system, access times, referring site.
- 5. **Communications**: correspondence via email, support tickets, event registrations.
- 6. **Applicant Data** (for employment): CV/resume, education, work history, references.

6. Purpose and Legal Basis of Processing

We process personal data for the following purposes, based on lawful grounds under Article 6 GDPR:

- Providing software and services (Contract Art. 6(1)(b)).
- Customer support and license management (Contract/Legitimate Interest).
- Marketing communications (Consent Art. 6(1)(a)).
- Website analytics and improvement (Legitimate Interest Art. 6(1)(f)).
- Compliance with legal obligations (Art. 6(1)(c)).
- Fraud prevention and security (Legitimate Interest).

7. Cookies and Tracking

Our websites use cookies and tracking technologies to:

- Maintain secure logins.
- Improve site performance and user experience.
- Collect analytics (e.g., through Google Analytics).

You may disable cookies via browser settings, but some features may not function correctly.

8. Third-Party Services

We may share or process personal data using trusted third parties, including:

- Payment Processors (e.g., PayPal, Stripe) to process payments.
- Marketing & CRM Platforms (e.g., HubSpot, Mailchimp).
- Analytics Providers (e.g., Google Analytics, Matomo).
- Cloud Hosting & IT Providers (e.g., AWS, Azure).
- **Professional Advisors** (e.g., legal, tax, accounting consultants).

These providers act as **Processors** under GDPR and are bound by contractual data protection obligations.

9. International Data Transfers

Since Winmostar Inc. is based in the U.S., personal data may be transferred outside the EEA. To ensure adequate protection, we rely on:

- Standard Contractual Clauses (SCCs).
- Other legally approved safeguards.

10. Retention Period

We retain personal data only as long as necessary to fulfill the purposes stated, or as required by applicable law (e.g., tax and accounting obligations). Once the purpose expires, we securely delete or anonymize the data.

11. Rights of Data Subjects

Under GDPR, you have the following rights:

- Right of Access obtain confirmation and a copy of your personal data.
- Right of Rectification correct inaccurate or incomplete data.
- Right to Erasure ("Right to be Forgotten") request deletion of personal data.
- Right to Restriction of Processing request limited processing.

- Right to Object object to processing based on legitimate interests or direct marketing.
- **Right to Withdraw Consent** withdraw consent at any time.
